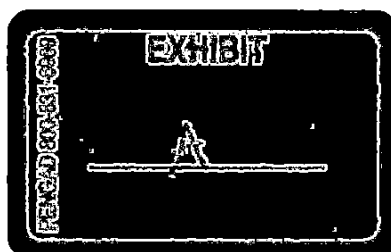

Information About the CPI-U

The CPI-U is a price index released by the Bureau of Labor Statistics. The 36 month period of 1982 - 1984 = 100 (base). More information about this data product is available at <http://www.bls.gov/cpi/>. The CPI-U for the Philadelphia metropolitan area is released every other month. It is also not available seasonally adjusted.

The 12-month percent change as reported by BLS is only reported to one post decimal digit. The index itself is reported to three post decimal digits. To increase the detail in this report, the 12-month percent change is calculated from the index to three post decimal digits.

The CPI-U for the Philadelphia/Wilmington/Atlantic City metro area will next be released by the Bureau of Labor Statistics (BLS) on Jan 12, 2022 for Dec 2021.
