A hearing shall be held on the 26th day of February, 2019, at 3:00 P.M. in Courtroom No. 1 in the Lebanon County Courthouse, 400 S. Eighth Street, Lebanon, Pennsylvania, to determine whether the relief requested in the Petition of the Lebanon County Board of Elections To Divide and Alter the Boundaries of Voting District shall be granted. Any person objecting thereto must file objections with court prior to such date.

After investigation, the Lebanon County Board of Elections finds the alteration of the Borough of Cornwall Election District 12 and the creation of new Election District 12-N and 12-S will promote the convenience of the electors and the public interests of the Borough of Cornwall by more effectively distributing the number of voters in said Election Districts and thus reducing the time it takes to vote in those Election Districts. 25 P.S. §2702.

Verbal descriptions of the boundaries of the altered Election District 12 and the newly formed Election District 12-N and 12-S reads as follows:

CORNWALL BOROUGH, NORTH AND SOUTH DISTRICTS:

The dividing line between the two election districts in Cornwall Borough begins at Freeman Drive on the west boundary and moves south along Freeman Drive to Alden Street. The dividing line continues on Alden Street until it becomes Burd Coleman Road. The dividing line leaves Burd Coleman Road at Rexmont Road. The line continues east on Rexmont Road until it goes south on Boyd Street, continues on Boyd Street until it reaches state route 322. The dividing line runs east on Route 322 until the Cornwall/South Lebanon municipal boundary line.

Cornwall Borough North is the area north of the dividing line.

Cornwall Borough South is the area south of the dividing line.

The Lebanon County Board of Elections hereby recommends that a proper alteration of the Borough of Cornwall Election District 12 and the creation of new Election Districts 12-N and 12-S is as shown on the map attached hereto said altered and created election districts having clearly visible physical boundaries conforming with census block lines from the most recently completed Federal decennial census.

The Lebanon County Board of Elections hereby recommends that a proper alteration of the South Londonderry Township Election District 31-C and the creation of new Election Districts 31-N and 31-M is as shown on the map attached hereto said altered and created election districts having clearly visible physical boundaries conforming with census block lines from the most recently completed Federal decennial census. 25 P.S. §2747. Verbal descriptions of the boundaries of the altered Election District 31-C and the newly formed Election District 31-N and 31-M reads as follows:

SOUTH LONDONDERRY TOWNSHIP, NORTH, MIDDLE, SOUTH DISTRICTS:

The dividing line between the three election districts in South Londonderry Township begins in the east of the township at the township line at South Mt. Pleasant Road, south along center of South Mt. Pleasant Road to Mt. Wilson Road/Route 241, southwest along center of Mt. Wilson Road/Route 241 to South Forge Road/Route 117, west along center of South Forge Road/Route 117 to East Patrick Road, west along center of East Patrick Road (which eventually becomes West Patrick Road) to Bachmanville Road, northwest along center of Bachmanville Road to county line.

The area north of this line within the boundaries of South Londonderry Township is the South Londonderry Township North and Middle Districts

The area south of this line within the boundaries of South Londonderry Township is the South Londonderry Township South District.

The dividing line between the South Londonderry Township Middle District and the South Londonderry Township North District begins at Horseshoe Pike on the western township boundary line. The dividing line follows Horseshoe Pike east until South Forge Road. The line then goes south on South Forge Road until the South Londonderry Township line with South Annville Township.

South Londonderry Township Middle District is the area south of this dividing line until the South Londonderry Township South District described above.

South Londonderry Township North District is the area north of this dividing line until the township boundary with North Londonderry Township.

The Lebanon County Board of Elections hereby recommends that a proper alteration of the Jackson Township Election District 12-W and the creation of new Election Districts 23-N and 23-W is as shown on the map attached hereto said altered and created election districts having clearly visible physical boundaries conforming with census block lines from the most recently completed Federal decennial census. 25 P.S. §2747.

Verbal descriptions of the boundaries of the altered Election District 23-W and the newly formed Election District 23-N and 23-W reads as follows:

JACKSON TOWNSHIP, EAST, NORTH, AND WEST DISTRICTS:

The dividing line between the three election districts in Jackson Township begins in the north of the township at the county line at Hilltop Road/Route 645, south along center of Hilltop Road/Route 645 to Rosebud Road, continuing south along center of Hilltop Road (no longer Route 645) to North College Avenue/Route 501, south along center of North College Avenue/Route 501 to township line/Myerstown borough line, south along township line/Myerstown borough line to South College Avenue/Route 501, south along center of South College Avenue/Route 501 to township line.

The area east of this line within the boundaries of Jackson Township is the Jackson Township East District and the area west of this line within the boundaries of Jackson Township is the Jackson Township North and West Districts.

The dividing line between the North and West Districts starts on W. Strack on the western boundary with North Lebanon. The line follows W. Strack Drive east until turning east onto Stracks Dam Road. The dividing line continues on Stracks Dam Road until it becomes N. Locust Street. The line continues on N. Locust Street south until turning east onto W. McKinley Avenue. The dividing line runs on W. McKinley until the boundary line with East Election District at Hilltop Road.

Jackson Township North Election District is the area north of the dividing line within Jackson Township. Jackson Township West Election District is the area south of the dividing line within Jackson Township.

NORTH CORNWALL TOWNSHIP, NORTH, SOUTH, AND WEST DISTRICTS:

The dividing line between the three election districts in North Cornwall Township begins in the east of the township at the township line at West Oak Street, west along center of West Oak Street to Church Road, west along center of Church Road to township line. The area south of this line within the boundaries of North Cornwall Township is the North Cornwall Township South District.

The dividing line between the North Cornwall North and North Cornwall West Districts is South 22nd Street at the north township boundary line that runs south to Walnut Alley on the south township boundary line.

North Cornwall Township North is the area east of South 22nd Street.

North Cornwall Township West is the area west of South 22nd Street.

SWATARA TOWNSHIP, NORTH AND SOUTH DISTRICTS:

The dividing line between the two election districts in Swatara Township begins in the west at the Swatara Township line on Greble Road. The dividing line continues on Greble Road running east until the township line with Bethel Township.

Swatara Township North District is the area north of Greble Road within the township.

Swatara Township South District is the area south of Greble Road within the township.
